

WHAT IS ILLICIT TRADE?



.........







CONTRABAND

Genuine tobacco products that are produced for lawful distribution in their market of intended destination but illegally diverted into a different market

COUNTERFEIT

Tobacco products that have been manufactured without the permission of the trademark rights holder

ILLICIT WHITES

Tobacco products that are generally legally produced in a market and which are smuggled into another market where they have limited or no legal distribution

UNDER DECLARATION

Tobacco products that are produced and distributed in the same country, a portion of which is not declared to the domestic tax authorities Illicit trade creates a cheap and unregulated supply chain of products, undermines efforts to offer novel legal products, damages legitimate businesses and intellectual property rights, stimulates organized crime, increases corruption, and reduces government tax revenue...





...illicit trade is approx. 10% of world consumption





...counterfeit and pirated products accounted for 3.3% of global trade - approx. 464 billion USD

...illicit trade annual negative impact equivalent to US\$2.2 trillion

The Munich Security Conference between 1.6 and 2.2 trillion

USD in illicit products flow globally

As per a KP&G 2022 Report Latin America represented 31.4% of total cigarette consumption or a total of 72 bn cigarettes v. EU at 8.2%
